- Session #2 after first session, patient felt slight improvement and the right leg can move slightly and gain back sensation. Treatment for second session last about 20 minutes. Pain further reduced.
- Session #3 after second treatment, patient could stand and walk slowly without crutches. Treatment for third session last about 20 minutes.

- Session #4 after third treatment session, patient felt he is back to normal. However, to cast the condition, fourth session was done. This is the last treatment session for the patient.
- After the four sessions of treatments, patient is free from problem since January 2005. He even able to take on a physically demanding career in Middle East.
